

## **Information regarding the International Driving Permit (IDP) for Bangladeshi drivers:**

**Authorised authority:** The Bangladesh Automobile Association (AAB) is the only authorised institution in Bangladesh that issues International Driving Permits (IDP).

**Validity of the IDP:** Valid for 12 months from the date of issue, applicable worldwide.

**What to do if your IDP is lost during its validity:** If your IDP is lost during its validity period, follow these steps:

- Bring a photocopy of your driving licence or licence book (if available).
- File a General Diary (GD) with this photocopy.
- Submit the GD copy to AAB.
- Pay a replacement fee of 500 BDT.
- You must apply in person.

If you do not have any photocopy of the licence, you will need to reapply for a new IDP and follow the standard application process.

### **Required documents for IDP application:**

- A copy of your valid passport.
- A copy of your National Identity Card (NID).
- A valid national driving licence (e-licence accepted; must have at least 1 month's validity).
- One passport-sized photograph.
- Four stamp-sized photographs.

**Licensing verification requirements:** If your driving licence was not issued by the Mirpur BRTA, you will need to have the licence verified at your regional BRTA office.

**IDP Fees:** IDPs are available in five categories:

**Processing and Delivery Options:** You can choose from the following delivery packages:

*\* For Super-Fast service, If the application is submitted on or before 12 PM (noon), delivery will occur on the same day. Applications submitted after 12 PM will be delivered on the next working day.*

**IDP Renewal:** Currently, renewal services are not available. Once the IDP expires, you will need to reapply with updated documentation.

**Submitting the Application:** You can download the application form from AAB's website, fill it out, and submit the required documents at the AAB office.

**Office Address:** 3B, Outer Circular Road, Mogbazar 1217, Dhaka, Bangladesh

**Does the applicant need to apply in person?** No, you can submit the documents through an acquaintance.

**Collecting the IDP:** The delivery date will be mentioned on the receipt provided at the time of payment. Please collect your IDP during office hours. **Office Hours:** Sunday to Thursday: 9:00 AM to 4:00 PM. The office will be closed on public holidays.

**Does the applicant need to collect the IDP in person?** No, anyone with the delivery receipt can collect the IDP.

**What to Do If There Is an Error on the IDP?** If any errors are found on the IDP, submit it to the office as soon as possible. If the error is the office's fault, it will be corrected free of charge. If the error is the customer's fault, it will be corrected for a fee of 500 BDT.

**Fake BRTA Licences:** If your national driving licence is not found in the DL checker: It will be considered fake, and you will not be eligible to apply for an International Driving Permit (IDP).
