### NOTES AND REQUIREMENTS

An International Driving Permit (IDP) is legally recognized translation of the holder's national driving licence which allows the holder to a motor vehicle of the specified class outside his own country. IDPs are issued under the Convention of Road Traffic 1949 to which Bangladesh is a signatory.

The Fédération Internationale de l'Automobile (FIA) and its member clubs, including the Automobile Association of Bangladesh (AA Bangladesh) are authorized by international law to issue IDP.

#### Requirements:

1. The application should be filled up in capital letter as per BRTA Licence.
2. BRTA Licence photocopy with at least one month validity on the date of application. (if the driving licence is not recognized online, an attestation from BRTA office is required on the licence copy).
3. NID photocopy.
4. Passport information page photocopy.
5. Photograph – 2 copy stamp size & 1 copy passport size.
